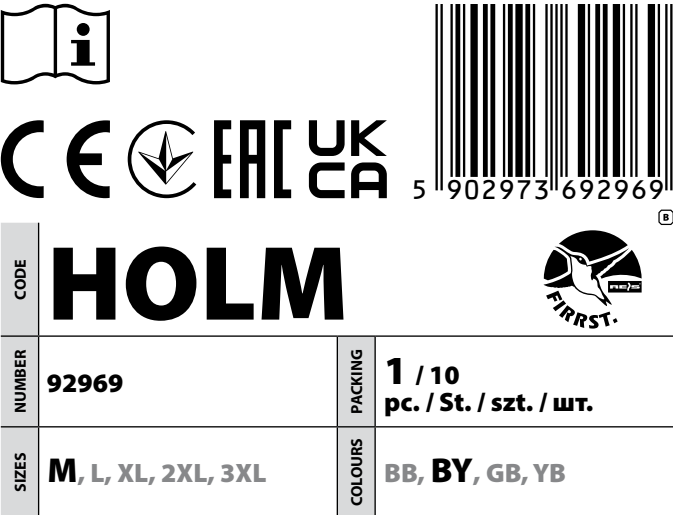

INSTRUKCJA I INFORMACJE DLA UŻYTKOWNIKÓW
PL Producent: RAW-POL STEFAŃSKI SPÓŁKA KOMANDYTOWO-AKCYNNA, Julianów 50, 96-200 Julianów, Polska. Ten produkt należy do środków ochrony indywidualnej (SOI) określonych w Rozporządzeniu Parlamentu Europejskiego i Rady (UE) 2016/425 i spełnia wytyczne tego rozporządzenia oraz w Rozporządzeniu 2016/425 w brzmieniu, w jakim zostało włączone do prawa prawnego. Zklasyfikowany został do kategorii I – tylko do minimalnych zagrożeń. **Standardy:** EN ISO 13688:2013+A1:2021, Odzież ochronna. Wyznaczenia ogólne; EN ISO 5470-2:2021, Płaskie wyroby tekstylne powleczone gumą lub tworzywami sztucznymi. Wyznaczenie odporności na ścieranie. Część 2: Urządzenie ścierające Martindale’a; Wewnętrzna specyfikacja techniczna producenta: RS22301:2018, RS22302:2018, RS22303:2018. **Produkt/opis:** Odzież ochronna. Szczegółowy charakterystykę produktu podano na rawpol.com. **Przeznaczenie:** Produkt ten jest środkiem ochrony indywidualnej mającym chronić użytkowników przed minimalnymi zagrożeniami, takimi jak: powierzchniowe urazy mechaniczne, które nie wymagają pomocy medycznej np. zadrapania będące rezultatem uderzenia w state przeciwy lub powstałe podczas zajmowania się ogrodnictwem; kontakt z gorącymi powierzchniami o temperaturze nieprzekraczającej 50°C (czas ekspozycji na kontakt z gorącymi powierzchniami podczas badania wynosił 30 sekund); czynniki atmosferyczne, które nie mają charakteru ekstremalnego tj. chłodna temperatura powyżej -5°C przy średniej intensywności pracy. Intended use: Protection against the following minimal risks: superficial mechanical injury that do not need medical attention, e.g. scratches resulting from bumping into fixed obstacles and gardening; contact with hot surfaces not exceeding 50°C (the time of exposure to the contact with hot surfaces during the test was 30 seconds); atmospheric conditions that are not of an extreme nature, i.e. cool temperature higher than -5°C at medium work intensity. Working time depends on many factors, such as wind strength or individual user. It is not possible to specify it precisely. More information about the conditions in which the tests were conducted can be obtained at rawpol.com or directly from a manufacturer, an authorized representative or an authorized distributor. The level of protection was obtained on the basis of tests carried out according to conditions described in the norms/specifications to which they apply. The product provides protection against the above risks and it is intended for use in the environments in which they occur.
