ATTENTION!
Earplugs should be adjusted, regulated and stored in accordance with the manual of the manufacturer or their authorized representative. Wear the earplugs non-stop in noisy areas. It should be advised that there are many factors influencing the level of protection (individual anatomical features, fitting skills), therefore users may be less protected than the given attenuation values.

CAUTION!
If the recommendations provided in the manual are not followed, the protection provided by the earplugs will be severely impaired which may cause damage or even loss of hearing.

In case the earplugs with an interconnecting cord, such earplugs should not be used where there is a risk that the connecting cord could be caught up during use. Even though the earplugs can be recommended as protection against the harmful effects of impulse noise, the noise reduction index bases on reduction of continuous noise and it may not be a relevant indicator for protection against impulse noise e.g. gunshot. Using the product as protection against this kind of threats for hearing can result in the loss of hearing nonetheless. In certain conditions the tolerance of this kind of noise varies for different people, therefore there is no method defining or ensuring relevant protection against impulse noise. If, during or after exposure to noise (including impulsive noise), your hearing deteriorates or ringing is heard or other discomfort in ears, the user should stop working and seek medical advice as there is a risk of hearing damage. All recommendations regarding the product should be strictly followed. The instruction has to be retained for the entire duration of use of the product.

Type: Disposable earplugs.

Size: The nominal diameter of the earplug: 7 - 12 mm.

Use: When used properly, the earplugs ensure protection from noise. They are used in the majority of environments related to dynamic noise of machines, such as workshops, production lines or when using mechanical saws, as well as noises from vehicles and aircraft. These earplugs can be recommended as protection against the harmful effects of impulsive noise, but it should be remembered that it is difficult to predict the required or actual level of hearing protection obtained during exposure to impulsive noise. The level of protection has been obtained on the basis of tests carried out in accordance with the conditions described in the standards/specifications to which they apply. The product provides protection against the above-mentioned hazards and is intended for use in the environments in which they occur. Always evaluate the hazards in a given work environment in order to verify whether a given product provides protection against all hazards present in this environment.

Use and handling:

It should be assured that hands and inserts are clean (it is recommended to wash hands before putting on the inserts) and that the inserts are not damaged. The attention should be drawn if there are no small contaminants on the earplugs that could irritate the ear canal. Dirty or damaged inserts and those that show visible signs of deformation and do not expand to their original shape should be replaced.

Fitting instruction:



1. Compress and roll to achieve the smallest diameter.
2. Insert the earplug quickly into the external auditory canal while pulling the auricle upward and a bit outward with the opposite hand.
3. Hold until the earplug fully expands (around 40 s).
4. Repeat with the second earplug.

If the earplug is placed correctly, only its tip can be felt under the fingers. If you feel that a significant part of the earplug is outside the ear canal, repeat the procedure.

After properly putting on the earplugs, the fit test should be performed in the place where there is noise by tightly covering your ears with your hands and then releasing them. If the earplugs are worn correctly, sounds are heard without any significant difference, regardless of whether the ears are covered or not. If the difference is significant, the earplugs should be removed and the new earplugs should be put on for proper fitting. If a correct fit is not possible, contact the person responsible for selecting personal protective equipment in the workplace to select other hearing protectors.

In the case of earplugs with a cord, the cord connecting them should fall natu-

Verwendung und Bedienung:

Stellen Sie sicher, dass Ihre Hände und Einlagen sauber sind (es wird empfohlen, Ihre Hände vor dem Einsetzen der Einlagen zu waschen) und dass die Einlagen nicht beschädigt sind. Stellen Sie sicher, dass sich auf den Ohrstöpseln keine kleinen Verunreinigungen befinden, die den Gehörgang reizen könnten. Verschmutzte oder beschädigte Einsätze sowie solche, die sichtbare Anzeichen einer Verformung aufweisen und sich nicht in ihre ursprüngliche Form ausdehnen, sollten ersetzt werden.

Montageanleitung:

rally and should not be tangled in anything, e.g. glasses if are present. Earplugs should be properly selected and fitted and used in accordance with this instruction to ensure optimal protection. Earplugs should be worn at all times during noise exposure and replaced when necessary, attention should be paid to their proper fit as well. If earplugs become loose, the level of protection may be reduced, so such earplugs should be replaced with new ones. Removing the earplugs: Hold the end of the earplug with the index finger and the thumb. Remove the earplug slowly simultaneously turning the earplug around its axis in order to remove it easily. **Warning:** Removing earplugs from the ear canal too quickly may damage the ear. In the case of earplugs with a string, do not remove the earplugs by pulling on the string. The product does not have additional equipment and replaceable parts. **Material:** Polyurethane foam (PU). Some substances may have a harmful effect on the product. Detailed information can be obtained from the manufacturer or their authorized representative.

Materials, from which the product is made shall not unfavourably impact the user's health or hygiene. However each substance contained in the product's material or which is the component of the product may be the allergen, e.g. cotton, leather, metal elements, latex, dyestuffs, etc. We recommend to try out this product for people who are specially susceptible.

Cleaning, maintenance and disinfection: The earplugs are single use and they do not require any special care. Dispose when used.

Storage: The product before use should be stored at the appropriate temperature, in dry and well ventilated place. Excessive air humidity, too high or low temperature or intense light may adversely affect its quality. The manufacturer is not responsible for the quality of the product stored contrary to the instructions. This may reduce the level of product protection.

Packaging: It is recommended to distribute (including transport) the product in the package with cardboard or plastic film. Loading, transport and unloading should take place in environment protecting against splashes, dirt and damage.

Shelf life: Disposable product, should be discarded after use. Before using the earplugs, make sure they are not damaged or torn. If so, replace them with a new pair. With proper warehousing the storage time of the product can be up to 4 years from the date of production.

Date of production is given on the smallest collective packaging. It is shown in the format MM/YYYY, explanation: the first two digits refer to the month of production, and the next four - the year of production.
