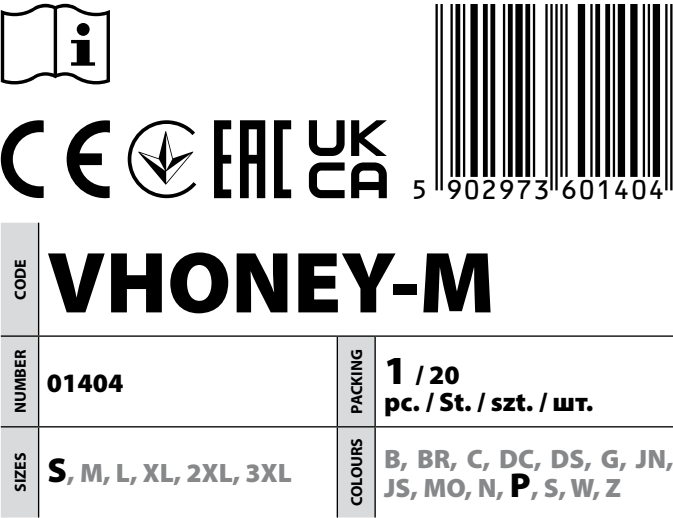

Producent: RAW-POL STEFAŃSKI SPÓŁKA JAWNA, 96-200 Julianów, 50, Polska.
Ten produkt należy do środków ochrony indywidualnej (SOI) określonych w Rozporządzeniu Parlamentu Europejskiego i Rady (UE) 2016/425 i spełnia wytyczne tego rozporządzenia. Zaklasyfikowany został do kategorii I – tylko do minimalnych zagrożeń.
Standardy: EN ISO 13688:2013 „Odzież ochronna. Wymagania ogólne”; EN ISO 12947-2:2016 „Tekstylia. Wyznaczanie odporności płaskich wyrobów na ścieranie metodą Martindale’a. Produkt/opis: Odzież ochronna. Szczegółową charakterystykę produktu podano na rawpol.com
